12. First Information contents :

Today, i.e. 31/01/2025, a joint teams comprising Kangpokpi District Police, 2 Coys of C/133Bn. CRPF, 2 Coys of 94 Bn CRPF, 1 Coy of Mahila Bn. CRPF, SDO Saikul Block led by Shri Tholu Rocky, MPS, Addl SP (L&O) Kangpokpi under the supervision of Shri, Manoj Prabhakar, IPS Superintendent of Police, Kangpokpi District, proceeded at Lhungjang Village at 1030 Hrs for carrying out Poppy destruction drive in the hill ranges of Lhungjang Village, Saikul Sub-Division, Kangpokpi District. The joint teams reached the spot at 1100 Hrs and successfully destroyed the illegal Poppy plants of about 45 (Forty five) acres at 1600 Hrs. The approximate value of the destroyed Poppy plants is calculated at about Rs. 50,00,00,000/- (Fifty crore) appx. The teams arrived back at 1700 hrs on the same day.

Hence, a suo-motu case under FIR No. 5(1)2025 SKL-PS u/s 18(b) ND & PS Act, 1985 is being registered for investigation..
