

Sir,

I have the honour to submit the following report for your kind information and necessary legal action thereof.

That on 01<sup>st</sup> January, 2026, at about 4:40 PM, while I was at my residence located at Uripok Achom Leikai, Imphal West District, Manipur, one Khaidem Ajitkumar Meitei (43) S/o Kh. Ibochou Singh of Nungei Mayai Leikai, Lilong, Thoubal District, Manipur along with his son and others aggressively came to my residence in search of me. There I confronted with him regarding some financial matter. He became very furious and he pulled out one pistol and cocked it and pointed it towards me, my wife and family members, and tried to shoot and kill us on the spot. Immediately, our other family members came at the spot and intervened the matter. After my family members tried to confront with them the said individual gave his pistol to one of his sons and let him escaped from the spot very swiftly. Being shocked and terrified by his violent and life threatening act. The entire incident left me and family members extremely frightened and mentally disturbed. Now I am under great psychological stress and have developed a constant sense of fear and insecurity.

Therefore, I humbly request you to kindly take up necessary legal action against the culprits for their criminal act of attempt to murder using arm and house trespass.


