Today i.e. 14/01/2026 at 02.30 pm, received a reliable information that some unknown armed miscreants suspected to be unlawful valley-based organization have collected a huge money as party funds from government offices, businessman's and the general public in Imphal area by intimidating them with dire consequences through illegal pressure or coercion. It is also highly suspected that the armed miscreants are operating from Guwahati, Assam by withdrawing the extorted money from ATM and UPI transactions. The criminal activities of the unknown armed miscreants suspected to be unlawful valley-based organization have created fear psychosis and panic among the general public which is likely to disturb the maintenance of harmony, public order and public tranquility in the state. However, the name of the specific organization is not yet ascertained.

Hence, a suo-motû case under FIR No. 12(01)2024 IPS U/s 308(5) BNS, 25(1-B) Arms Act has been registered against the unknown armed miscreants suspected to be unlawful valley-based organization for investigation.
