

Subject :- Report.

Sir,

I have the honour to report that today i.e. 14/01/2026 at about 01:40 p.m. received specific information from 33 AR by SAFE/TBL (special action force for extortion) that some active cadres of KYKL(SOREPA), a banned unlawful organisation are loitering in and around Uripok Achom Leikai area for prejudicial activities like extortion, monetary demand from Imphal West and Thoubal District area. Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. Superintendent of Police (Ops) Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal immediately rushed to Uripok Achom Leikai area at around 02:50 p.m. after giving necessary information to SP control room Imphal West and conducted frisking and checking of suspected persons. In that, one person was seen in a very suspicious manner. On his suspicious nature, he was detained for verification.

On preliminary verification he identified himself as Shamulalaltpam Arbin Sharma @ Phirepa 19 yrs. s/o. Sh. Shyamkeshor Sharma of Nongpok Sekmai Makha Leikai a/p Salam Mamang Leikai, Imphal West District, an active member of KYKL(SOREPA).

On his body search one Redmi 9i along with 1 (one) Jio SIM card bearing mobile No. 8787355081 were recovered from his possession.

On spot verification he disclosed he is working under the command of Arepa @ Bungtombi @ Bungo of KYKL(SOREPA). He further disclosed that he and his associate namely Keilhelakpam Telheiba Mangang @ Thoiba @ Lanyanba were involved in threatening at a residence located at Ghari Imphal West District for monetary demand, under the instruction of Arepa @ Bungtombi @ Bungo of their organisation and he provides logistic support to his organisation.

Hence, he was arrested at 03:10 p.m. from Uripok Achom Leikai near Shemrock School and seized the above-mentioned Redmi 9i along with 1 (one) Jio SIM card bearing mobile No. 8787355081 at 04:26 p.m. of the same day at DHQ Thoubal from his possession by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography could not be done at the spot as an information was received from intelligence sources that some organised public mob may be initiated to forcefully free the arrested accused person. Hence, all the documentation works were prepared at DHQ, Thoubal at about 04:40 p.m. of the same day and recorded through e-Sakshya portal.

The arrested person mentioned above along with seized articles are being handed over to you for taking further necessary legal action against him.
