Sub:- Report for obstruction, intimidation, damage to Property, and assault to my old aged mother.

Sir,

I have the honour to state the following few lines for your kind perusal and further necessary action.

That, on 19/01/2026 at @ 10.30 AM while my mother namely R.K (O) Memtombi Devi (67 yrs) was alone at our residence located at Yaiskul Yumnam Leikai, Imphal West District, Manipur, a group of people numbering about 10 including womenfolk led by Yumnam Atangba Singh (50 yrs), Yumnam Hemanta Singh (55 yrs), Yumnam Ramkumar Singh (50 yrs) and Yumnam Bode Singh (27 yrs) entered inside our premises and immediately they intimidated and assaulted my mother by using abusive languages. They also threatened my mother with dire consequences. The mob became very aggressive and violent, and started attacking at our entrance gate and they also destroyed and removed the drain cover steel at our entrance gate. It is also pertinent to mention that these people also threw garbage and house hold leftovers in our gate every day. Their conduct clearly reflects increasing aggression, hostility, intimidation, provocation and a clear intention to cause grievous injuries to my mother and my family members. This is not an isolated incident. These individuals have been repeatedly indulging in similar acts during our absence. They regularly: -

1. Intimidation and assault to old aged mother.
2. Damage our property.
3. Throw garbage and leftover food in front of our gate,
4. Create public nuisance and obstruction,
5. Intimidate and provoke us to engage in conflict,
6. Threaten us by stating that "the law and police cannot do anything against them".

Their continuous actions amount to criminal intimidation, mischief, trespass, and harassment and are causing serious disturbance to our family's safety, dignity, and peaceful existence and my family is no longer feel safe residing in our own house.

It, is therefore, requested your good self to kindly book the above-mentioned persons along with their associates and to take up necessary legal action according to the law of the land at the earliest.
