Sir,

I have the honour to report that an attempt to murder case was happened on 26/01/2026 in my house at around 2.00 am by some goons. Yesterday i.e., 25/01/2026 at around 9.30 pm, they first came at our locality at Keishamthong Elangbam Leikai, Imphal and met women folks (Meira paibies) and warned the Meira paibies that they will kill me. After advising the goons by the Meira paibies, they left at around 10.00 pm of the same day. Unfortunately, the said goons came again at our house with gun and forcibly jumped down through our pond searching for me. When they called out my name, my sister-in-law namely Brajabshimayum (O) Bidyadhori Devi faced them and even they pointed gun to my sister-in-law and her daughter B. Kajal Sharma and they (goons) shot a gun in the name of blank fire. One of the goons had been caught by our local members and family members and two of them escaped. The caught gunda is Keisham Roshan Singh of Irom Pukhri Mapal, the person that shot the gun is Keisham Goon Singh of Irom Pukhri Mapal and the third gunda is Keisham Kishan Singh of Irom Pukhri Mapal.

In this regard, I would like to complaint in the attempt to murder case against them.

Hope you will file this case as a matter of social issue and take it seriously.
