Sir,

I have the honour to state that on 25/01/2026 at about 08:00 PM, my husband namely Keisham Roshan Singh (38) S/o (L) Keisham Sarojkumar of Keishamthong Irom Pukhri Mapal, Imphal West District, Manipur along with his younger brother namely Keisham Gulshan (33) and his cousin brother namely Keisham Kishan Singh (35) S/o K. Ranjit Singh of Keishamthong Irom Pukhri Mapal, Imphal West District, Manipur were returned home after attending their friend's wedding at Keishamthong Thangjam Leirak, Imphal. Thereafter, my husband reached home shortly and after sometime he was informed that his brother Keisham Gulshan was physically assaulted and push down at a drain by one Brajabashimayum Upendro Sharma S/o (L) B. Jagadish Sharma of Keishamthong Elangbam Leikai, Imphal West District, Manipur under the influence of alcohol. Upon receiving the information, I along with my husband immediately went to check and found my brother-in-law fallen at a drain in front of our house with severe injury on his eye and he had also lost one gold ring. Immediately, he was evacuated to RIMS Hospital for medical treatment. After, returning from RIMS hospital my brother-in-law went to the residence of the said B. Upendro Sharma to talk about the matter peacefully. In the meantime, my husband along with his cousin brother Keisham Kishan Singh also followed Keisham Gulshan. However, at around 11.40 pm of the same day, when they reached at the residence of Brajabashimayum Upendro Sharma they were intercepted by unknown localities and the family members of the said Upendro, which led to a heated confrontation. During the confrontation, they were physically assaulted by the mob using deadly weapons like spade, etc. In order to escape from the unruly mob, my brother-in-law Keisham Gulshan Singh fired one blank round from his license pistol as self-defence. Thereafter, Keisham Gulshan and Keisham Kishan Singh manage to escape from the spot, but my husband was caught by the unknown localities and the families of the said Upendro Sharma. His hands were tied with a rope, he was blindfolded, wrongfully confined and brutally assaulted, resulting in severe injuries. He was detained till late night by the unruly mob with blindfolded.

It is therefore, requested your good self to kindly take up necessary legal action in accordance with law.


