Sir,

I have the honour to report that today i.e. 28/01/2026 at about 6:30 AM while conducting random frisking and checking at the opposite road side of the Nupilal Complex by an escort team of SP-Imphal West, spotted 2 (two) individuals pulling one scooter TVS Centra, red in colour bearing Regd.
