Sir,

I have the honour to state that today i.e. 28/01/2026 at 10:50 AM received an information from our own source that some underground outfits are loitering in and around Thangmeiband area. After reducing the information, a combined uniform team of CDO/IE and civil team of CDO/IE, rushed towards Thangmeiband area after giving prior information to the control room of Imphal West and SP/IE. Immediately, I along with my team rushed towards Thangmeiband area. On reaching Thangmeiband Lourung Pural Leikai area two individuals were found in a suspicious manner inside their gate. On verification they identified themselves as Yumnam Tingting Singh (35 Yrs.) S/o. (L) Y. Ibotombi Singh of Thangmeiband Lourung Pural Leikai, P.O & P.S-Imphal, Imphal West district, Manipur and Yumnam Singsing Singh (30 yrs.) S/o. (L) Y. Ibotombi Singh of Thangmeiband Lourung Pural Leikai, P.O & P.S-Imphal, Imphal West district, Manipur. On spot verification, they disclosed that they are real brothers and they are drug users. On further checking their living room. found 16 nos. of plastic vials suspected to be contained heroine No. 4 in their bedroom. So, immediately the matter was informed to Shri Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE and he also arrived at the spot.

On weighing all the recovered 16 nos. of plastic vials containing suspected to be heroin No. 4 by using a weighing machine, it weighs 6 (six) grams and without the plastic vials the suspected heroin No. 4 weighs approximately 2 (two) grams. Thereafter, the suspected heroine No. 4 is put inside the plastic vials and again the 16 numbers of plastic vials are put inside a transparent plastic marked as "S" and the same was seized on production by Yumnam Tingting Singh at 12.35 PM by observing formalities in presence of witnesses and Shri Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE. Hence, Yumnam Tingting Singh (35 yrs.) and Yumnam Singsing Singh (30 yrs.) were arrested at 12.45 PM and 12.50 PM respectively by observing formalities.


The arrested persons along with the seized item were handed over to you for taking up further necessary legal action.
