

Today, i.e. 10/01/2026, at around 12.50 PM received information that members of one of the valley based insurgent group United National Liberation Front - UNLF(P) demanded a sum of 25 paise per litres share from all the petrol pumps in Imphal valley area by threatening the owners/proprietors/managers of the petrol pumps with dire consequences. As a result, petrol pump across valley districts of Manipur started shut down indefinitely in protest against the threat of the militant outfit.

The criminal activities of UNLF(P) directly engage in credible threats, violence to the owners/proprietors/managers of the petrol pumps with an intent to cause fear and alarm to the general public in order to collect party funds. It also affects the law and order of the state.

Hence, a suo-mottu case under FIR No. 07(01)2026 IPS U/s 351(2)/61(2) BNS & 16/17 UA(P) Act has been registered against the leaders and members of the banned outfit UNLF(P) for investigation.


