Subject :- Report.

Sir,

I have the honour to report that today i.e. 13/01/2026 at about 02:00 p.m. received specific information from 31 AR by SAFE/TBL (special action force for extortion) that some active cadres of KYKL(SOREPA), a banned unlawful organisation are loitering in and around Kangabam Leikai area for prejudicial activities like extortion, monetary demand from Imphal West and Thoubal District area. Acting on the information, a joint team of Commando Unit Thoubal including women police personnel led by Inspt. K. Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri Hizam Devendra Singh, MPS, Addl. Superintendent of Police (Ops) Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal immediately rushed to Kangabam Leikai area at around 03:10 p.m. after giving necessary information to SP control room Imphal West and conducted frisking and checking of suspected persons. In that, one person was seen in a very suspicious manner. On his suspicious nature, he was detained for verification.

On preliminary verification he identified himself as Keithelakpam Telheiba Mangang @ Thoiba @ Lamyamba 23 yrs. s/o. K. Dilip Mangang of Kwakeithel Heinou Khongnembi Imphal West District an active member of KYKL(SOREPA).

On his body search one Redmi Note 7 along with 2 (two) Airtel SIM card bearing mobile Nos. I) 6909548886 and II) 7085196563 were recovered from his possession.

On spot verification he disclosed that he joined KYKL (SOREPA), in the month of December, 2025 through one Arepa @ Bunglombi @ Bungo of KYKL(SOREPA) and worked under his command and instructed him to serve demand letters and threat to the general public. He is providing logistic support to his organisation. On further verification, he disclosed that one of his associates namely Goody @ Phirepa was staying at Kwakeithel Thokhom Leikai area.

Hence, he was arrested at 04:20 p.m. from Kangabam Leikai near Lairembi and seized the above-mentioned Redmi Note 7 along with 2 (two) Airtel SIM card bearing mobile Nos. I) 6909548886 and II) 7085196563 at 06:20 p.m. of the same day at DHQ Thoubal from his possession by observing formalities.

On follow up action the joint team immediately rushed at Kwakeithel Thokhom Leikai on his pointing detained Goody @ Phirepa along with one Yamaha bike black in colour bearing registration No. MN01M 7715. On verification he identified himself as Kouhoujam Goody Meitei @ Phirepa 23 yrs. s/o. K. Devkumar Meitei of Bishnupur Ward No. 10, Joypur Khunou Bishnupur District, an active member of KYKL(SOREPA).

On his body searched one Poco x3 pro along with one Jio SIM card bearing mobile No. 9366519532 were recovered from his possession.

On further verification he disclosed that he joined KYKL(SOREPA) in the month of December, 2025 through one Arepa @ Bunglombi @ Bungo of KYKL(SOREPA) and worked under his command and instructed him to recruit new cadres and to extort in the valley District

He is providing logistic support to his organisation. He further disclosed that one of his associates namely Ichan was staying at Kwakeithel Bazar.

Hence, he was arrested at 05:05 p.m. of 13/01/2026 from Kwakeithel Thokchom Leikai near ILDS Hospital and seized the above mentioned Poco x3 pro along with one Jio SIM card bearing mobile No. 9366519532 and Yamaha bike black in colour bearing registration No. MN01M 7715 at 06:31 p.m. of the same day at DHQ Thoubal by observing formalities.

On follow up action the joint team immediately rush at Kwakeithel Bazar area on his pointing Ichan was detained for verification. On verification she identified herself as Lajshram Ichan Devi (@ Sangita 30 yrs. d/o. (L) L. Ibohanbi Singh of Wabagai Terapishak Kakching District. w/p Kwakeithel Akham Leikai an active member of KYKL(SOREPA).

On her body searched one poco C16 along with one jio SIM card bearing mobile No. 9366219338 and a sum of Rs. 6000/- (six thousand) only of 500 denomination (500 X12) were detected from her possession.

On further verification she disclosed that she is working under the command of her elder brother Arepa @ Bungtombi @ Bungo of KYKL(SOREPA) now staying at Bangladesh. She further disclosed that she was involved in recruiting new cadres and extortion in the valley District. She is providing logistic support to her organisation.

Hence, she was arrested at 05:15 p.m. of 13/01/2026 from Kwakeithel Bazar near Girls High School and seized the above-mentioned articles i.e. poco C16 along with one jio SIM card bearing mobile No. 9366219338 and a sum of Rs. 6000/- (six thousand) only of 500 denomination (500 X12) at 06:42 p.m. of the same day at DHQ Thoubal by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography could not be done at the spots as an information was received from intelligence sources that some organised public mob may be initiated to forcefully free the arrested accused person. Hence, all the documentation works were prepared at DHQ, Thoubal at about 06:45 p.m. of the same day and recorded through e-Sakshya portal.

The arrested persons mentioned above along with seized articles are being handed over to you for taking further necessary legal action against them.




