12. First Information contents:

In continuation with 'War on Drugs' today i.e., 06/01/2026, a poppy destruction drive conducted at Khabung Hill Range (Upper and Lower Khabung village), Lat 25. 299137<sup>0</sup> and Long. 94. 093488<sup>0</sup> Senapati-PS under the initiative of the Senapati District Anti-Narcotic Task Force (ANTF). The operation was carried out under the supervision of Addl. SP (NH-2), Nodal Officer of ANTF, and under the overall supervision of SP/Senapati. The combined was led by SDPO-SPT consisting of teams from Senapati-PS, one section each from B-109/F-36/C-142 CRPF, 10 (ten) personnel of RL-SPT, 4 (four) officials of Senapati District Forest Division, equipped with drone for aerial reconnaissance.

Out of 32 acres of poppy field identified during poppy cultivation survey earlier, the team has successfully destroyed 31 acres today. About 1 acre was found barren/discontinued. Half bag of fertilizers and salt, pipe for irrigation, spray pumps etc. found at the site were also destroyed. The approximate value of the destroyed is Rs. 21, 70, 000/- (twenty one lakhs and seventy thousand) only.

The District ANTF will continue the destruction drive to eliminate illicit poppy cultivation and has reiterated its strong resolve to sustain intensive anti-poppy operations across the district.

Hence, a Suo-Moto case under **FIR No. 01(01)2026 SPT-PS U/S 18(b)/46 ND&PS Act 1985** has been registered for investigation.



Out of 32 acres of poppy field identified during poppy cultivation survey earlier, the team has successfully destroyed -31 acres today. About 1 acre was found barren/discontinued. Half bag of fertilizers and salt, pipe for irrigation, spray pumps etc. found at the site were also destroyed. The approximate value of the destroyed is Rs. 21, 70, 000/- (twenty-one lakhs and seventy thousand) only.

The District ANTF will continue the destruction drive to eliminate illicit poppy cultivation and has reiterated its strong resolve to sustain intensive anti-poppy operations across the district.
