I have the honour to submit you the report that Based on input regarding mov of contraband/narcotics on Joupi - Mombi - Chakpikrong Rd, a party from COB Mombi was launched at 1330h on 19 Jan 2026 which placed a dynamic MVCP in village Mombi (notified area) (RM 410135). At around 1645 hrs, the party intercepted two individuals on a kenbo bike. The pillion rider tried to evade the MVCP and was caught by the stops. Upon detailed search of the individuals and two wheeler, a total of 22 soap cases of brown sugar was recovered (13 were found on person on first peddler and 09 cases on person on second peddler).
