Sir,

With due regards, I beg to state that today i.e. 25/01/2026 at about 03.10 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Kakmayai Lamkhai for using offensive act against State Security Forces and CAPF.

On receipt of the information, joint team of Commando Unit, Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, MPS, Addl. SP (Ops) Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 31 AR (1-Officer, 1-JCO and 15 personnel) have rushed to the spot immediately and launched a massive operation at 05.30 a.m. On searching and found the undernoted articles from the spot and seized at 06.41 a.m. by observing formalities.

2. 4 (four) Nos. of 36 HE hand grenade,
3. 6 (six) Nos. of IED,
4. 1 (one) No. of INSAS LMG Magazine,

7. 42 (forty two) Nos. of SLR ammunition,
8. 70 (seventy) Nos. of AK ammunition,

10. 3 (three) Nos. of 12 bore cartridge,
11. 5 (five) Nos. of detonator.

The massive searched Operation was conducted from 05.30 a.m. to 07.00 a.m. on the same day.
