

With due respect, I have the honour to report that today i.e. 06/01/2026 at around 4:30 pm while performing normal frisking and checking at Nepali Khuti, Senapati along NH-2 by a joint team of Special Operation Team (SOT) and one team of CRPF D/78 QAT under the supervision of SP/SPT



intercept one Bolero Bearing Registration No. AS01DS-9963 coming from Imphal towards Mao side was stopped.

On checking the vehicle, detected carrying suspected to be Opium in the Bolero (white in colour). As such, DC/SPT has been intimated and requested to depute one Magistrate. Accordingly, Shri. Panii Ngaonii, SDC/Senapati, Manipur was deputed for taking further legal necessary action.

On arrival of the Executive Magistrate in his presence, the driver namely Nantu Deb (44) yrs s/o Milan Deb, village- Mahishashan, PO & PS- Mahishashan, District-Karimganj, Assam removed 11(Eleven) packets suspected to be Opium from the vehicle which were kept concealed inside the spare tyre which was fixed in the back of the vehicle. The 11(Eleven) packets suspected to be opium were weighed by using weighing machine in the presence of Executive and witnesses and weighed 11.264 Kgs (including weight of plastic cover). The approximate value is Rs 7,70,000 (Seven Lacs Seventy thousand). The 11(Eleven) packets suspected to be opium were seized in the presence of Executive Magistrate and witnesses by preparing formal seizure memo. The detained person namely Nantu Deb (44) yrs s/o Milan Deb, village- Mahishashan, PO & PS- Mahishashan, District-Karimganj, Assam were formally arrested by observing formalities at 5:30 pm. During the seizure and arrest, videos or photos was not uploaded in eSakshay as I don't have an authorised eSakshay account. I have recorded the video of the seizure and arrest in the phone.
