



12. First Information contents:

Today i.e., 13/01/2026, a poppy destruction drive was conducted at Sadim Hills Range, Lat. 25.365326°, Long. 94.02824° P.S – Senapati, under the initiative of the Senapati District Anti-Narcotic Task Force (ANTF). The operation was carried out under the supervision of Addl. SP (L/O), Addl. SP (NH-2) (Nodal Officer of ANTF) and under the overall supervision of SP - Senapati. The combined team was led by Addl. SP (NH-2) – Senapati along with Shri Shivin, IPS (Probationer) of 77 RR Batch consisting of 2 teams from Senapati-PS & RL-SPT, B-109/F-36/C-142 Bn CRPF, Executive Magistrate Senapati and Forest Department, Senapati. Forest officials of Senapati Forest Division provided drone support for aerial reconnaissance.

About 30(thirty) acres of poppy field were destroyed during the destruction drive today. 3(three) bags of Urea and 2(two) bags Salt, one small well, water pipes



for irrigation of Poppy Field, few Kgs off poppy seeds etc. found at the site were also destroyed.

The District ANTF will continue the destruction drive to eliminate illicit poppy cultivation and has reiterated its strong resolve to sustain intensive anti-poppy operations across the district.

Hence, a Suo-Moto case under **FIR No. 04(01)2026 SPT-PS U/S 18(b)/46 ND & PS Act 1985** has been registered for investigation.

The District ANTF will continue the destruction drive to eliminate illicit poppy cultivation and has reiterated its strong resolve to sustain intensive anti-poppy operations across the district.
