



With due respect, I have to state a few lines that on 7/01/2026 following the death of one drug user namely Late Shangkhil Sheltlung (26) yrs S/o Shangkhil Angdon of Angbrasu village, Chandel District in which a UD (Unnatural Death) case was taken up under vide UD case No.1/CDL-PS/26 Dated 07/01/2025. As disclosed by the accomplice of the deceased namely Mr. Anthony in his statement which reveals that on 24/12/2025 evening, they, (1) Wl. Ninthson Anal (2) (L) Shangkhil Sheltlung Lamkang and (3) Ps. Anthony @ Angpu went and bought drugs from one individual namely Mr. Kalni Ruwndar near Oil pump, Chandel for consumption. Accordingly today i.e 15/01/2026 at around 1220 hrs., I along with my team pickup on Mr. Kalni Ruwndar (35) yrs S/o Dilover Ruwndar of Larong Khullen Village P.O & P.S Tengnoupal, District Chandel from his Uncle's resident namely Hmanshel Ruwndar of Abungnikhu village, District Chandel in connection with the above mentioned UD case and following the investigation of the same. On preliminary interrogation of the said person, he disclosed that he is a regular drug user and also peddler and has been continuing the same for last 3/4 years.

So, I request you to kindly take up further necessary legal action against him according to the law.




