Respected Sir,

I, am Malem Thongam, C/O Th. Amuba Meitei (Late) resident of Maibakhul Mayai Lelikai, Imphal East Manipur, currently a social activist conducting a "Cycling for Manipur peace" expedition, wish to bring to your immediate notice a grave matter of criminal intimidation and threat to public safety.

The facts of the case are as follows:

Background: Since October 2, 2025, I have been cycling from New Delhi to Manipur, covering over 2,300 km to spread the message of peace, communal harmony, and the restoration of normalcy in our state. My mission is peaceful and non-political.

The incident: On December 17, 2025, the Committee Tribal Unity (COTU), based in Sadar Hills, Kangpokpi, issued a formal press statement. In this statement they warned me against entering or passing through Kangpokpi District on my scheduled route (National Highway 2) on December 19th, 2025.

Natural of threat: COTU has labelled my peace mission as "Provoking tension: and explicitly stated that they would "not be responsible for any untoward incident" if I proceed. This constitutes a direct threat to my life and physical safety. Furthermore, by attempting to block a National Highway they are illegally restricting my fundamental right to free movement guaranteed under Article 19 of the Constitution of India.

Criminal Intendent: The statement appears designed to incite communal disharmony and create fear among the public during a sensitive period. Despite my 24-hour ultimatum for them to withdrawn the statement, they have failed to do so, compelling me to seek legal intervention.

I, therefore, request you to register an FIR against the leadership and spokespersons of COTU under the relevant sections of the Bharatya Nyaya Sanhita (BNS), including but not limited to:

Section 196: Promoting enmity between different groups on ground of religion, race, place of birth, residence, language, etc.

Section 351(Criminal intimidation): For the threat issued regarding "untoward incident",

Section 126(Wrongful restraint): for attempting to obstruct my passage on a public highway,

Section 353: Statemen conduct to public mischief.

Give the volatile situation in the state and the specific threat to my safety as I approached Kangpokpi and Imphal, I urge you to take immediate cognizance of this matter and provide necessary security for the completion of my peace mission.
