

12. First Information contents:

Today i.e. 06/02.2026 at 1:00 PM it has come to the light that some days back certain unknown persons, acting individually or in concert with others, were involved in acts of extortion, wherein they intentionally put individuals under fear of injury to person and or property and thereby dishonestly induced them to deliver money and other valuable security.

It is further alleged that the accused persons used to demand money to the non-local shopkeepers/businessmen by using the name of one Thouba @ Wanglen @ Sintha mobile number 6909225545 and threatening the shopkeepers with dire consequences and used intimidation and coercive tactics to extract illegal gratification. The acts were carried out repeatedly and systematically causing fear and mental distress to the victims. It is highly believed that their commander namely Thouba @ Wanglen @ Sintha who is a leader of an armed miscreants group indulging in extortion activities in Imphal City is presently operating from Delhi.

The acts of the said unknown armed miscreants along with their commander tantamount to the commission of offences punishable for Extortion, Criminal intimidation, Criminal conspiracy and Arms act.

Considering the necessary to register a case against the accused persons, a case under FIR No. 08(02)2026 City PS U/S. 308(5)/351(3)/61(2) BNS and 25 (1-B) Arms Act has been registered on Suo-Mottu for investigation.


