

Sir,


With due respect and regard, I am to report that on 12/01/2026 at around 12:30 pm my 1(one) Gold chain (16 ½ San approx.), 1 (one) Gold Necklace (16 San approx.), 2(two) Gold pairs of ear ring (12 San & 3 San approx.), 3 Nos. of Gold finger ring (4 San, 2 ½ San & 2 San approx.), 1 No. of Gold arm chain (7 San approx.) total 63 San of Gold value about Rs. 18,90,000/- (Eighteen Lakhs ninety thousand only) and cash about Rs. 30,000/- approx.. were stolen way by unknown person, taking the advantages of absents of family members by breaking the lock of the Amirah. The Gold ornaments were kept inside an Iron Amirah under lock and key.
