I have the honour to state that today i.e. on 17/01/2026 at around 9:48 pm, an information was received from SP control/Thoubal that 112 (Emergency Police Call) informed over phone that 3 (Three) unknown persons were coming at Lilong Turel Ahanbi Salam Makha near TAYV Club with one stolen Honda Activa and searching for any person to sell the stolen Honda Activa. On received of the said information, I along with police team of Lilong PS rushed to the said area and found three unknown persons near one Honda Activa blue in colour without registration number on the road side of Lilong Turel Ahanbi Salam Makha near the TAYV Club. On seeing our police team, they tried to fled away riding the Honda Activa and our team detained the three unknown persons there for verification. On verification, the rider identified himself as Chanambam Maneshwor Singh (23) S/O Ch. Rajeshwor Singh of Samaram Mamang Leikai and the pillion riders as Konthoujam Thoiba Singh (26) S/O Late K. Surendra Singh of Samaram Maning Leikai and Ningthoujam Chinglemba Singh (21) S/O N. Dilipkumar Singh of Samaram Mayai Leikai. They disclosed that the said Honda Activa is stolen one and they were searching for any



person to sell it. On their body search, one mobile handset i.e. one Nokia Mobile Phone model No. TA-1396, having IMEI No. 355107517109140, (Sim slot 1) and IMEI No. 35510751719157 with Airtel Sim card bearing No. 9233281674 was recovered from Ningthoujam Chinglemba Singh (21) S/O N. Dilipkumar Singh of Samaram Mayai Leikai and one Samsung Mobile phone blue in colour with Jio Sim card bearing No. 7005311606 was recovered from Konthoujam Thoiba Singh (26) S/O Late K. Surendra Singh of Samaram Maning Leikai.

Surendra Singh of Samaram Maning Leikai and Ningthoujam Chinglemba Singh (21) S/O N. Dilipkumar Singh of Samaram Mayai Leikai were arrested at 10:05 pm, 10:07 pm & 10:09 pm respectively by observing formalities.
