The brief fact of the case is that today i.e. 24/03/2025 one Internally Displaced person because of the ethnic conflict in the State since 3rd May, 2023, I stay in a rented house at Kangpokpi ward No. 9 during this tumultuous period, I came to learn that a suit was instituted at the Court of the Civil Judge Senior Division, Senapati, Manipur on 16/12/2024 against my name. When I enquire about the matter at the above mentioned Court a case was instituted bearing Original Money Suit No. 2 of 2024 where Mrs. Golmei Dingchungliu aged about 29 years W/o Mr. Dinkachin Golmei a resident of Kairang Road, Sangakpham Poumai Colony, P.O. Lamlong, P.S. Heingang, Imphal East district, Manipur as Plaintiff and Mrs. Palhing Chongloi aged about 55 years W/o (L) Janglenthang Chongloi Previously a resident of New Checkon, P.O. & P.S.-Porompat, Imphal East District, Manipur and presently residing

at K.S. Lhangnom Village, P.O. Motbung P.S. Gamnom Saparmeina, Kangpokpi Di strict, Manipur as Defendant base on Promissory Note dated 09/09/2022 and Money Receipt Dated 09/09/2022 for allegation against Mrs. Palling Chongloi that the defendant had borrowed Rs. 10,00,000/- (Rupees Ten lakhs) only and it was also written in the petition that a demand notice/Legal Notice dated 04/09/2024 was sent by the Plaintiff through his Counsel and was received on 06/09/2024 by the defendant by hand through his Counsel which the defendant Palling Chongloi had signed on that Demand Notice.

However, Palling Chongloi who is the Defendant in the above mentioned case has been represented by his son Paolun Chongloi by submitting the Indian Union Driving Licence bearing No. MN06 20220002439 as his identity proof in the Court. On 20/01/2025 Mutual agreement was signed between the Plaintiff and the Defendant on the condition that the Defendant being the second party agreed to give and transfer Patta being registered in her name i.e. Mrs. Palling Chongloi under Pata No. 224(New), Covered by C.S. Dag No. No. 4434 measuring an area of 0.0247 Hectare situated at Revenue Village No. 26 (A) - Nongpok Ingkhol, Imphal East District, Manipur with structures standing there on to the Plaintiff who is the plaintiff of the above mentioned case in liu of the borrowed amount of Rs. 10,00,000/- (Rupees Ten lakhs) only, which was borrowed in the year 2022. On 21/02/2025 both the parties filed joint application praying for disposing the abovementioned case, again on 08/03/2025 the matter was put up in the National Lok Adalat, held at District & Session judge Senapati Complex, the matter was heard, the petitioner Counsel was present but both the Parties was absent because of the law and order situation in the district.

That, I never borrowed Rs. 10,00,000/- (Rupees Ten lakhs) only from Mrs. Golmei Dingchungliu. I have never received Demand Notice/Legal Notice from any person (s), I have never ever signed a mutual Agreement in respect to Patta No. 224(New), Covered by C.S. Dag No. No. 4434 measuring an area of 0.0247 Hectare situated at Revenue Village No. 26 (A) - Nongpok Ingkhol, Imphal East District, Manipur with structures standing.

Given these circumstances, I urge your esteemed office to arrest and to take swift legal action against these person(S)1. Mrs. Golmei Dingchungliu aged about 29 years W/o of Mr. Dinkachin Golmei a resident of Kairang Road, Sangakpham Poumai Colony, P.O. Lamlong, P.S. Heingang, Imphal East district, Manipur, (2). Paolun Chongloi who pretend to be defendant son a resident of New Checkon Imphal East, Porompat, MN-795001 (surname & address as according to fake driving licensed) but the correct surname of Paolun is Touthang instead of Chongloi and his correct address is KS Lhangnom Village ,Saitu Gamphazol Sub Division , P.S. Gamnom Sapameina, Kangpokpi district, Manipur instead of New Checkon Imphal East, Porompat, MN-795001 who were the perpetrators to ensure justice

Hence, a regular case under FIR No. 11(3) 2025 KPI-PS u/s 319 (2)/318(4)/335/336/337/338/3(5) BNS has been registered for investigation.

I, am writing to bring to your notice that being Internally Displaced person because of the ethnic conflict in the State since 3rd May, 2023, I stay in a rented house at Kangpokpi ward No. 9 during this tumultuous period, I came to learnt that a suit was instituted at the Court of the Civil Judge Senior Division, Senapati, Manipur on 16/12/2024 against my name. When I enquire about the matter at the above mentioned Court a case was instituted bearing Original Money Suit No. 2 of 2024 where Mrs. Golmei Dingchungliu aged about 29 years W/o Mr. Dinkachin Golmei a resident of Kairang Road, Sangakpham Poumai Colony, P.O. Lamlong, P.S. Heingang, Imphal East district, Manipur as Plaintiff and Mrs. Palhing Chongloi aged about 55 years W/o (L) Janglenthang Chongloi Previously a resident of New Checkon, P.O. & P.S.-Porompat, Imphal East District, Manipur and presently residing at K.S. Lhangnom Village, P.O. Motbung P.S. Gamnom Saparmeina, Kangpokpi Di strict, Manipur as Defendant base on Promissory Note dated 09/09/2022 and Money Receipt Dated 09/09/2022 for allegation against Mrs. Palhing Chongloi that the defendant had borrowed Rs. 10,00,000/- (Rupees Ten lakhs) only and it was also written in the petition that a demand notice/Legal Notice dated 04/09/2024 was sent by the Plaintiff through his Counsel and was received on 06/09/2024 by the defendant by hand through his Counsel which the defendant Palhing Chongloi had signed on that Demand Notice.

On 21/02/2025 both the parties filed joint application praying for disposing the abovementioned case, again on 08/03/2025 the matter was put up in the National Lok Adalat, held at District & Session judge Senapati Complex, the matter was heard, the petitioner Counsel was present but both the Parties was absent because of the law and order situation in the district.

That, I never borrowed Rs. 10,00,000/- (Rupees Ten lakhs) only from Mrs. Golmei Dingchungliu. I have never received Demand Notice/Legal Notice from any person (s), I have



never ever signed a mutual Agreement in respect to Patta No. 224(New), Covered by C.S. Dag No. No. 4434 measuring an area of 0.0247 Hectare situated at Revenue Village No. 26 (A) - Nongpok Inghol, Imphal East District, Manipur with structures standing.

Given these circumstances, I urge your esteemed office to arrest and to take swift legal action against these person(S)1. Mrs. Golmei Dingchungliu aged about 29 years W/o of Mr. Dinkachin Golmei a resident of Kairang Road, Sangakpham Poumai Colony, P.O. Lamlong, P.S. Heingang, Imphal East district, Manipur, (2). Paolun Chongloi who pretend to be defendant son a resident of New Checkon Imphal East, Porompat, MN-795001 (surname & address as according to fake driving licensed) but the correct surname of Paolun is Touthang instead of Chongloi and his correct address is KS Lhangnom Village ,Saitu Gamphazol Sub Division , P.S. Gamnom Sapameina, Kangpokpi district, Manipur instead of New Checkon Imphal East, Porompat, MN-795001 who were the perpetrators to ensure justice. As an internally displaced person grappling with emotional trauma, I was unable to report the incident promptly.

As such, it is my appeal to your good office to look and take initiative of utmost protection of my Homestead land along with all the standing structures for further theft and damage.
