13. First Information contents:

The brief fact of the case is that on 08/04/2025 at 2:30 am, a joint patrolling under the instruction of OC/Kangpokpi-PS and under the supervision of SP/Kangpokpi was conducted by a team of Kangpokpi Police and A/112 CRPF along NH-2 between T. Khullen and Koubru Laikha, while coming back from Koubru-Laikha, some individuals were seen stopping commercial Trucks suspected to be extorting money from the driver of the trucks at a workshop (PK vehicles & Parts servicing centre) on NH-2. On seeing the combined security force, the individuals tried to flee away from the scene by taking advantage of the darkness. However, with prompt action of the joint teams, the teams managed to overpower and apprehended one individual after a brief chase at around 3:30 am on the same day. On spot questioning, he admitted that he had committed extortion along with one individual namely Mr. Hunter, a cadre of KLO/KLA and 3 (three) other individuals who are not known to him from the trucks plying along NH-2. One mobile smart phone (One Plus, Model-CPH2467) bearing IMEI (1) - 867207071135878, IMEI (2) - 867207071135860 along with JIO SIM Card No. 9233084099 along with Rs. 25,000/- (Twenty five thousand only) in cash were also recovered from his possession at the spot. Thereafter, he was taken to Kangpokpi Police Station for proper verification. On further verification, he is identified as Lunminthang Guite (27) S/O Ngamjapao Guite of Khamenlok Village, P.O - Pangei, P.S - Sagolmang, Kangpokpi District, Manipur.

Hence, a case is being registered under FIR No. 14(4)2025 KPI-PS u/s 308(2)/310(6)/3(5) BNS for investigation.
