No.AS02DC-8730 carried out by some individuals at near **TRENDS MALL**, Kangpokpi along NH-2. Immediately, a joint teams comprising QRT of KPI-PS and A/112 Bn. CRPF, Kangpokpi under the instruction of OC/Kangpokpi-PS and under the supervision of SP/Kangpokpi rushed to the spot. On seeing the police teams, 1(one) extortionist managed to escape from the spot by taking the advantage of heavy traffic flow and crowd. However, with the prompt action of the police teams, one individual was overpowered and picked up from the spot. Thereafter, he was taken to Kangpokpi-PS for proper verification. On verification, he is identified as Hensonpiek Vaiphei @ Henson (23) yrs. s/o Kimhoilam Vaiphei of Singda Kuki village, PO: Lamshang, PS: Kangchup, A/P: Thingkangphai Relief Camp, PO:Tuibong, PS: Churachandpur, Distt: Churachandpur. On preliminary questioning, he admitted that he had committed extortion from the above mentioned Tata truck as instructed by one of his friends known as Sasang. One mobile smart phone POCO (Model-M2103K19PI) bearing IMEI (1) - 862201052402212, IMEI (2) - 862201052402220 bearing SIM No. 9362270715 recovered from his possession.

Hence, a case is being registered under FIR No. 15(4)2025 KPI-PS u/s 308(2)/310(6)/3(5) BNS for investigation.
