13. First Information contents:

The brief fact of the case is that on 17/04/2025 at about 2:30 pm, received reliable input from source that one Tingneikim @ Kimboi Khongsai (42) w/o Sehminlal Khongsai temporarily residing in a rented house at Kangpokpi ward no. 13, near Nute Kailhang, I.T road is selling illegal drugs at her rented house at the aforementioned address. Upon receiving this information, a police team of KPI-PS including women police personnel and QRT of 112 CRPF Bn. led by ASP(LO) KPI under the supervision of SP/Kangpokpi raided the residence of Tingneikim @ Kimboi Khongsai. During the process, the said individual was found inside her rented house and on the preliminary questioning, she was given option whether to surrender the illegal drugs or the police team to check it. On giving the option, she finally took out the concealed illegal drugs in one black polythene package containing soap cases (suspected to be brown sugar) from her wooden Almirah. On opening the package, found 3 & C. On weighing, A weighs 39 grams, B weighs 39 grams and C weighs 37 grams including the weight of the soap cases. The soap cases which were marked A, B and C were kept inside one transparent polythene bag and marked as Lot-1. On weighing Lot-1, it was found 117 grams including the weight of the soap cases and transparent polythene bag.

Particulars of the seized articles

- 3 (three) numbers of soap cases (suspected to be containing Brown Sugar) weighing 117 grams including the weight of soap cases and transparent polythene package.
- 01 (one) VIVO Y21 mobile smart phone IMEI (1): 862822057697611, IMEI (2): 862822057697603, bearing Jio Simcard No. 7005831131.
- 01 (one) PAN Card in the name of Kimboi Khongsai bearing number DHLPK6993Q.

Sir,

I have the honour to state that on 17/04/2025 at about 2:30 pm, while I was on duty as Highway Patrol received reliable input from source that one Tingneikim @ Kimboi Khongsai (42) w/o Sehminlal Khongsai temporarily residing in a rented house at Kangpokpi ward no. 13, near Nute Kailhang, I.T road is selling illegal drugs at her rented house at the aforementioned address. Upon receiving this information, a police team of KPI-PS including women police personnel and QRT of 112 CRPF Bn. led by ASP(LO) KPI under the supervision of SP/Kangpokpi raided the residence of Tingneikim @ Kimboi Khongsai. During the process, the said individual was found inside her rented house and on the preliminary questioning, she was given option whether to surrender the illegal drugs or the police team to check it. On giving the option, she finally took out the concealed illegal drugs in one black polythene package containing soap cases (suspected to be brown sugar) from her wooden Almirah. On completion of legal formalities, the signature of duty Magistrate, police witnesses (as there was no public willing to stand for witnesses) and Tingneikim @ Kimboi were obtained on the Extraction and Weighing Memo and Seizure Memo at 3:30 pm on the same day at her rented house campus, Kangpokpi Ward No. 13 near IT-Road Nute Kailhang for necessary legal action. She was arrested at 3:35 pm.

1. 3 (three) numbers of soap cases (suspected to be containing Brown Sugar) weighing 117 grams including the weight of soap cases and transparent polythene package.

3. 01 (one) PAN Card in the name of Kimboi Khongsai bearing number DHLPK6993Q.

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested accused person and seized items are handed over to you for taking up further necessary legal action please.
