The brief fact of the case is that on 13/05/2025 from intelligence (INT) team of DIG CRPF, Kangpokpi that few unknown miscreants are extorting Rs. 10,000-20,000/- (ten thousand to twenty thousand) from shopkeepers in Kangpokpi Bazar. That, on 14/05/2025 at around 3:10 pm, received input from 3 Core Intelligent Bureau (CIB), Indian Army that one cadre affiliated to Kuki Revolution Front (KRF) under SoO group, Mr. Paogoulun Kipgen @ Paogoulun @ Gogou (29) yrs. s/o (L) Seigin Kipgen (#6009396451) of L. Songtun village, PO & PS- Kangpokpi, Kangpokpi District, Manipur is extorting money from shopkeepers in Kangpokpi Bazar.

Immediately, a joint team of KPI-PS, 112 Bn. CRPF and 3 CIB under the supervision of SP/Kangpokpi launched a flash CASO (Cordon & Search Ops) in the area and apprehended the above individual at adjacent to Kanak Photo Studio, NH-2, Kangpokpi bazar on the same day at 3:15 pm. One Redmi-8 Mobile Phone, one SIM card bearing No-6009396451, 3(three) blank sheets of Tourist embarchation Card and 1(one) Mahindra THAR-CRD e (Black) bearing Regn. No. NL07H-1608 were recovered from his possession. The accused person along with the seized items are handed over to KPI-PS for necessary legal action.

Hence, a Su o-Moto case under FIR No. 19(5)2025 KPI-PS u/s 308 (1), (2)/310(6) BNS & 17 UA (P) Act has been registered for investigation.
