

13. First Information contents:

The brief of the case is that on 21/07/2025 received a specific intelligence input regarding the presence of weapon cache hidden by unknown armed miscreants in general area between Maohing village and Changoubung Village about 7 Kms North West of Kangpokpi Police Station, Kangpokpi District. On receipt of the input, a Combined Search Operation (CASO) comprising one platoon of A/112 Bn. CRPF led by AC T.S.T Baite and Unit QAT of 112 Bn. CRPF led by Inspt. Arvind Kumar under the supervision of 2IC Mukesh Taterway of 112 Bn. CRPF; 2(two) column of 16 AR led by Major NM Singh and AC Vivek kumar Singh and one team of Kangpokpi Police led by SI Rex Haotinal Doungeel under the overall supervision of SP/Kangpokpi had immediately launched a combined search operation in the said general area on the same day from 0600 hrs to 0815 hrs. by using Handheld Metal Detector (HHMD), Deep Search Mine Detector (DSMD) & Sniffer Dog. During the search of the area, the combined teams recovered the following arms and ammunition from the spot at 0810 hrs and Ops terminated at 0815 hrs. However, no arrest could be made in the process as the unknown miscreants had already fled from the scene: -




