13. First Information contents:

The brief fact of the case is that 24/07/2025 12:40 pm received information about the presence of drugs in the house of PF Adaphro (35) W/o Rocky Tibi Teinamei at T. Khullen village which was brought by one drugs-peddler namely Lungdinibou Thiumai (52) S/o Mahenthui Thiumai of Khundong Khunkhaiba, PS-Tamei, Tamenglong District, Manipur, through one vehicle (Tata Xenon bearing unknown no, black in colour) coming from Imphal side. At the same time, information was also received about the concealment of unaccounted cash amounting to Rs. 40,00,000/- (forty lakhs) only at the same house. Immediately, joint team of KPI police led by Shri Tholu Rocky, Addl. SP(LO)/KPI and OC/KPI-PS assisted by QRT team led by SI Lienkhohao Khongsai and women police teams of KPI-PS and SPT-PS led by W/SI Nengneilam Sauni, team of G/112 CRPF led by Inspt. Diwan Singh Adhikari and commandant Leopard Mukesh Taterway and team of SP-QRT D/94 CRPF under the overall instruction of SP/Kangpokpi rushed to the spot and carried out cordon and search at the said house at 1:20 pm. During which, Lungdinibou Thiumai (52) S/o Mahenthui Thiumai of Khundong Khunkhaiba, PS-Tamei, Tamenglong District, Manipur a/p Kirha village, near Airport Junction, Dimapur, Nagaland and PF Adaphro (35) W/o Rocky Tibi Teinamei of T. Khullen village were picked up from the house for examination. In the meantime, one lady who was later identified as S. Boibina (29) D/o TK Shakpa of T.Khullen village was seen throwing away a big sack and cartoon box suspected to be containing illegal contraband drugs beyond the fencing at the back yard of the house in suspicious manner. On being asked, Boibina confessed that what she had thrown away was none other than contraband illegal drugs.

On being confirmed about the presence of illegal contraband drugs, one Executive Magistrate was informed and requested for his presence at the spot and also, the place where the objects containing illegal drugs that was thrown away by Boibina was kept under surveillance by the police and CRPF personnel until the arrival of the Executive Magistrate.

Based on the preliminary questioning of the three individuals, they revealed the details of the co-conspirator involved in trafficking. Among them, one S. Poubinah Teinamei, elder sister of S. Boibina was on her route (NH-2) in one Hyundai Creta B/R.No.NL07CC-5761 (white colour) coming from Dimapur to receive the illegal drugs from Lungdinibou Thiumai at T. Khullen. So, immediately information was passed and alerted Senapati Police and accordingly, S. Poubinah Teiname was intercepted at Senapati Check Gate. On being verified the identity, she was escorted till her house at T. Khullen village (PO).

On arrival of executive magistrate/Kangpokpi at the spot, Boibina was made to open the sack and cartoon box and found 19 numbers of square shape box-type packed with black polythene and wrapped with yellow and black cello tape. On opening each box, found 11 (eleven) soap cases each covered with transparent polythene. On counting the soap cases, found a total of 209 (Two hundred and nine) soap cases (suspected to be containing Brown Sugar). In the meantime, another similar 6 (six) square shape box-type containing 64 numbers of soap cases which were hidden beneath the chicken-coop were recovered. The total number of soap cases recovered at the spot is 273 (Two hundred and seventy-three). So, in the presence of executive magistrate, Lungdinibou Thiumai, S. Boibina, PF Adaphro and police witnesses, weighing and extraction of the recovered 273 soap cases (suspected to be containing Brown Sugar) were done in which the recovered 273 (Two hundred and seventy three) were marked 1, 2, 3.....till 273. The soap cases marked 1-54 were kept inside one transparent polythene bag and marked as Lot-1, the soap cases marked 55-108 were kept inside one transparent polythene bag and marked as Lot-2, the soap cases marked 109-162 were kept inside one transparent polythene bag and marked as Lot-3, the soap cases marked 163- 216 were kept inside one transparent polythene bag and marked as Lot-4 and the soap cases marked 217-273 were kept inside one transparent polythene bag and marked as Lot-5.

On weighing the Lots, Lot-1 weighs 2.084 kgs, Lot-2 weighs 2.118 kgs, Lot-3 weighs 2.150 kgs, Lot-4 weighs 2.092 kgs and Lot-5 weighs 2.266 kgs respectively including the weight of the transparent polythene bags and soap cases. The total weight of the recovered soap cases (i.e 273) is found 10.71 kgs including the weight of the soap cases and transparent polythene bags.

On further questioning of whereabouts of the presence of the cash amount of Rs 40,00,000/- (Forty Lakhs) utilized for drugs trafficking. PF Adaphro initially reluctant to disclose however, she

Finally surrendered the concealed amount of Rs 40 Lakhs (40 bundles of 500 notes, 30 bundles of 500 notes and 50 bundles of 100 notes separately packed) from the wardrobe installed inside one bed room on the ground floor of the house. On further searching of the house, cash amounting to Rs 19, 49, 850/- (Nineteen lakhs forty- nine thousand eight hundred fifty) only were recovered from the same room and another 9,60,000/- (Nine Lakhs Sixty thousand) were recovered from the first storey. And also, on checking the vehicle of one Hyundai Creta B/R.No.NL07CC-5761 driven by S. Poubinah which was brought by Senapati police at the spot, cash amounting to Rs 30,00,000/- (Thirty Lakhs) was recovered. Finally, the total cash recovered at the spot is totalled as Rs 99,09,850/- (Ninety-nine lakhs nine thousand eight hundred and fifty).

The recovered items such as 273 soap cases (suspected to be containing Brown Sugar), cash amount of Rs 99,09,850/- (Ninety-nine lakhs nine thousand eight hundred and fifty) and other articles were seized in the presence of Executive Magistrate, witnesses and apprehended persons by preparing a formal seizure memo at 4:20 pm by obtaining their signatures. The apprehended persons were also arrested at 4:30 pm in presence of witnesses by preparing a formal arrest-memo. Short clips of videography and photographs of the process of seizure of contraband drugs and other articles were taken and stored in a pendrive (HP 16GB) for future reference.

On weighing the Lots, Lot-1 weighs 2.084 kgs, Lot-2 weighs 2.118 kgs, Lot-3 weighs 2.150 kgs, Lot-4 weighs 2.092 kgs and Lot-5 weighs 2.266 kgs respectively including the weight of the transparent polythene bags and soap cases. The total weight of the recovered soap cases (i.e 273) is found 10.71 kgs including the weight of the soap cases and transparent polythene bags.

On further questioning of whereabouts of the presence of the cash amount of Rs 40,00,000/- (Forty Lakhs) utilized for drugs trafficking, PF Adaphro initially reluctant to disclose however, she finally surrendered the concealed amount of Rs 40 Lakhs (40 bundles of 500 notes, 30 bundles of 500 notes and 50 bundles of 100 notes separately packed) from the wardrobe installed inside one bed room on the ground floor of the house. On further searching of the house, cash amounting to Rs 19,49,850/- (Nineteen lakhs forty-nine thousand eight hundred fifty) only were recovered from the same room and another 9,60,000/- (Nine Lakhs Sixty thousand) and 4 (four) empty soap cases were recovered from the first storey. And also, on checking the vehicle of one Hyundai Creta B/R.No.NL07CC-5761 driven by S. Poubinah which was brought by Senapati police at the spot, cash amounting to Rs 30,00,000/- (Thirty Lakhs) was recovered. Finally, the total cash recovered at the spot is totalled as Rs 99,09,850/- (Ninety-nine lakhs nine thousand eight hundred and fifty).

The recovered items such as 273 soap cases (suspected to be containing Brown Sugar), cash amount of Rs 99,09,850/- (Ninety-nine lakhs nine thousand eight hundred and fifty) and other articles were seized in the presence of Executive Magistrate, witnesses and apprehended persons by preparing a formal seizure memo at 4:20 pm by obtaining their signatures. The apprehended persons were also arrested at 4:30 pm in presence of witnesses by preparing a formal arrest-memo. Short clips of videography and photographs of the process of seizure of contraband drugs and other articles were taken and stored in a pendrive (HP 16GB) for future reference.


