First Information contents: Today i.e. 11-02-2026 at 7:15 pm received information that on the same day at around 7:02 pm, one i10 grand car bearing registration No. MN06LA 9385 driven by an unknown driver coming from Imphal side via Thoubal towards Wangjing side knocked down an unknown male Cyclist along NH-102 at Khangabok Bazar while the unknown male Cyclist was crossing the road, due to rash or negligent driving on the part of unknown driver of the said i10 car (b/regn.no. MN06LA 9385) and the unknown male Cyclist. As a result, the unknown male Cyclist sustained injury and evacuated to District Hospital, Thoubal for medical treatment. Both i10 car and the bi-cycle were also partly damaged.
