On seeing the police team, the two miscreants tried to escape from the scene however, they were overpowered and picked up from the spot who were later identified as Paominthang Kipgen (32) @ England S/o (L) Thenmang Kipgen of Molhoi Village, PO/PS – Churachandpur, Churachandpur District, Manipur and Seigoulal Kipgen (33) @ Gogou S/o (L) Tongkai Kipgen of Molnoi Village, P.O – Motbung, P.S – Gamnom Saparmaina, Kangpokpi District, Manipur. During the process, the unknown tata truck had already left the spot towards Imphal. Later, the two miscreants were brought to Kangpokpi Police Station for proper verification and after being verified, they were arrested however, no seizure was made from their possession.
