13. First Information contents:

The brief fact of the case is that today i.e. 04/09/2025 at 5:50 pm received information about the presence of one drug peddler namely Luntinlen Chongloi @ Boilen (36) yrs. S/o Lunsat Chongloi of Jangnoi village, PO/PS-Saikul, Lhungtin Sub-Division, Kangpokpi District in the rented house of Senpu Hangshing at Phungtin Veng, Ward No. 15, Kangpokpi who is suspected to be in possession of contraband drugs. Immediately, joint teams of KPI police led by Addl. SP(H/Q) accompanied by SDPO/KPI team, SDPO/GSPM team, OC/KPI-PS team, one column of 16 AR and team of A/112 CRPF under the overall instruction of SP/Kangpokpi rushed to the spot and carried out cordon and search at the said residence at 6:20 pm by preparing one House Search memo. During which, no incriminating article was found in the house and Luntinlen Chongloi was taken to KPI-PS for further examination where he disclosed that he did not possessed drugs but on the same day at around 4:30 pm, he assisted one individual namely Lamkholen Hangshing @ Boilen (33) S/o Khuphao Hangshing of Tingpibung village, PO/PS-Saikul, Kangpokpi District, Manipur in collecting 5(five) numbers of soap cases (containing drugs) somewhere toward the western side of Keithemanbi village in his Motor Bike (Avenger) B/R. No. MN-01AL-6490 and after which Lamkholen Hangshing boarded in one Bolero from Keithelmanbi Bridge and proceeded towards Saikul. Luntinlen Chongloi returned back to Phungtin Veng where he was pick-up.

On received of the above information, using technical support, the location of Lamkholen Hangshing was traced and instantly, the OC/SKL was informed and alerted vide WT Msg No. 36/KPI-PS/2025 dated 04/09/2025 which resulted into the interception of Lamkholen Hangshing along with the driver cum owner of the Bolero B/R. No. AS-14F-2863 namely Lunlenthang Hangshing @ Anthony (22) yrs S/o Seilal Hangshing of Tingpibung village, PO/PS- Saikul, Kangpokpi District, Manipur near Ichaigojang village. Both the two individuals along with the said vehicle were brought at Kangpokpi-PS by the Saikul Police team.

On arrival at KPI-PS campus, both the two individuals were tactfully examined separately and finally Lamkholen Hangshing disclosed the presence of drugs inside the vehicle. Having confirmed the presence of drugs in the vehicle no further checking was done in order to observe formalities. So, as per requested by SDPO/KPI, 1 (one) Executive Magistrate namely Shri L M Len Singsit arrived at KPI-PS campus. With the direction of the Executive Magistrate, the two detainees were given option whether to surrender the illegal drugs or the police team to check it. On giving the option, Lamkholen Hangshing surrendered five soap cases that were concealed behind the left side of the rear seat. The five soap cases were marked 1, 2, 3, 4 and 5. On weighing, 1 weighs 36 grams; 2 weighs 50 grams; 3 weighs 42 grams; 4 weighs 43 grams and 5 weighs 45 grams including the weight of the soap cases. The total weight is 216 grams including the weight of the soap cases.

The recovered 216 grams containing of suspected Brown Sugar and other articles were seized in presence of Executive Magistrate, witnesses and detained persons at 8:40 pm by preparing a formal seizure memo and also obtained their signatures. The 3(three) accused persons were formally arrested at 8:45 pm by observing formalities.





S/o Lunsat Chongloi of Jangnoi village, PO/PS-Saikul, Lhungtin Sub-Division, Kangpokpi District in the rented house of Senpu Hangshing at Phungtin Veng, Ward No. 15, Kangpokpi who is suspected to be in possession of contraband drugs. Immediately, joint teams of KPI police led by Addl. SP(H/Q) accompanied by SDPO/KPI team, SDPO/GSPM team, OC/KPI-PS team, one column of 16 AR and team of A/112 CRPF under the overall instruction of SP/Kangpokpi rushed to the spot and carried out cordon and search at the said residence at 6:20 pm by preparing one House Search memo. During which, no incriminating article was found in the house and Luntinlen Chongloi was taken to KPI-PS for further examination where he disclosed that he did not possessed drugs but on the same day at around 4:30 pm, he assisted one individual namely Lamkholen Hangshing @ Boilen (33) S/o Khuphao Hangshing of Tingpibung village, PO/PS-Saikul, Kangpokpi District, Manipur in collecting 5(five) numbers of soap cases (containing drugs) somewhere toward the western side of Keithemanbi village in his Motor Bike (Avenger) B/R.
