The brief fact of the case is that on 18/09/2025 at around 11:40 pm, received an input regarding extortion being carried out by some miscreants at Daili village near workshop, along NH-2. Accordingly, a joint team of SDPO/KPI, OC/KPI-PS, 112 CRPF & special team of KPI-PS led by self under the supervision of SP/KPI, immediately rushed towards the spot and seen one unknown miscreant stopping one D.I Yodha from a distance. On seeing the police teams, one unknown miscreant who was extorting money tried to escape from the scene however; he was overpowered by the combined teams and detained at the spot. On spot interrogation, he was identified as Satminhao Kipgen @ Mimin (21) S/o Thanglet Kipgen of Kangpokpi Ward No. 16 who had extorted money from D.I Yodha bearing Regn. No. WB17-6552 in the name of KLA(Kuki Liberation Army). Meanwhile, on examination of the driver of the D.I Yodha at the spot, he stated that he was demanded Rs. 1000/- (One thousand) only however, he paid Rs. 100/- (One hundred) only. Later, the miscreant was brought to Kangpokpi Police Station for proper verification and after being verified to be involved in extortion in the name of KLA, he was arrested on 19/09/2025 at 12:30 am. The following items were seized from his possession on the same day at 12:35 am.
