13. First Information contents:

The brief fact of the case is that today i.e., 24th September 2025 at @ 5:45 pm, a team of OC/KPI-PS, Special team KPI-PS comprising women police led by SDPO/KPI under the supervision of SP/KPI while conducting random frisking and checking of vehicles at near Koubru Laikha along NH-2 came across one Scorpio bearing Regn No. MN06L-4091 (Black in colour) proceeding towards Saparmeina driven by one Lunkim Seiminthang Khongsai (30) S/o Lunkim Paokholun Khongsai of Saichang Village, Kangpokpi District, Manipur. On thorough checking of the vehicle and body search of the driver and 2(two) occupants namely Kimkhochong Haokip (43) D/o (L) Tongthang Haokip of Saitu Village , P.O-Motbung, P.S-G. Sapormeina , Kangpokpi District, Manipur and Hatneichong Haokip (41) D/O Seingam Haokip of Saitu Village, P.O-Motbung, P.S-G. Sapormeina, Kangpokpi District, Manipur, in the presence of gazetted Police officer, SDPO/Kangpokpi, 2(two) soap cases in different colours (blue & olive green) which 1(One) of the Soap cases (partially opened) and 3(three) nos. of identical tobacco(khaini) tin containers suspected to be containing brown sugar were recovered from the possession of the 2(two) occupants. By observing necessary formalities under ND&PS Act, the two soap cases were marked 'A' and 'B' whereas, the three tobacco(khaini) tin containers were marked 'C', 'D' and 'E'. On weighing, found 'A' weighs 35 grams, 'B' weighs 40 grams, 'C' weighs 8 'D' weighs 7 and 'E' weighs 7 grams including the weight of soap cases and tobacco (khaini) tin containers. The total weight is 97 grams including the weight of soap cases and tobacco(khaini) tin containers. The recovered

suspected drugs along with the following other articles were seized at 7:15 pm and the apprehended persons were arrested at 7:20 pm on the same day at the spot in the presence of Gazetted Police Officer and witnesses. However, the formalities being conducted on the highway and due to the darkness of the atmosphere, independent witnesses could not be found.

After observing the necessary formalities in presence of the Gazetted Police Officer and witnesses, the arrested persons along with the seized items were taken to Kangpokpi Police Station for further legal procedure. On preliminary questioning, the 2(two) occupants revealed that they have received the 2(two) soap cases suspected to be containing brown sugar along 3(three) nos. of tobacco(khaini) tin containers from Thongkhohou Khongsai (30) @Bempu, S/o Thangjangam Khongsai of Aihang Village, Chothe Khunou, Chandel District, Manipur at Kangpokpi. With the help of technical assistant, the location of Thongkhohou Khongsai was traced and he was arrested at the workshop near Chonghang Veng at 9:00 pm on the same day by a police team of KPI-PS and seized 1(one) mobile phone, Oppo smartphone bearing Sim 1.- 9366230301 and Sim 2-8131933290 and IMEI 1-862906058456851 and IMEI 2- 862906058456844 AND 1(one) Aadhar card bearing no. 822199150972.

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Hence, a case is being registered under FIR No. 31(9)2025 KPI-PS u/s 21(b)/29/60(3) ND & PS Act for investigation.
