The brief fact of the case is that on 11th October 2025 at 2:50 pm received an information regarding the movement of drugs peddler namely Hensonkap Vaiphei (25) yrs @ Rhino S/o Henkam Vaiphei of Kamuching village, PS-Maphou Dam, A/p residing at Leikop Relief Camp along NH-2 from one source person. Immediately, the complainant had engaged his source man giving cash for the price for one soap case on the pretext of buying drug in order to locate whereabouts of the said drug peddler. After few minutes, source man reported back to the complainant handing over to him one soap case that was bought from the aforesaid drug peddler as per entrusted and informed him the location of Hensonkap Vaiphei at Kalapahar. Instantly, team of OC/KPI-PS, Special team KPI-PS comprising women police led by SDPO/KPI under the supervision of SP/KPI rushed to the said location at Kalapahar at 3:40 pm and found the said drug peddler (Hensonkap Vaiphei) along with one Paominthang Khongsai (18) yrs @ Paopu S/o Chungminlun Khongsai of Bongmol village, PS- Kangpokpi. On preliminary questioning whereabouts of the drug, Hensonkap Vaiphei revealed that he had sold one soap case and the remaining 3(three) soap cases were put inside one black polythene, wrapped with his sweat-shirt and then kept inside the under seat-storage of his vehicle NTORG B/R. No. AS 05S-7808. Hensonkap Vaiphei also disclosed that the said vehicle was hired by one Mr Boipu Vaiphei (27) S/o Mangkholien Vaiphei of Zalenbung village, PS-Litan, Ukhrul District, Manipur who is attending post funeral program near ITI Relief camp, Kangpokpi. Immediately, the two individuals were taken and rushed to the said location where Mr Boipu Vaiphei was found engaging himself in preparing feast for the people attending the post funeral program. Due to inconveniences of darkness and crowded place of function, Mr Boipu was picked-up from the spot (PO) at around 5:45 pm and brought to KPI-PS along with the vehicle (NTORG B/R.No. AS 05S-7808) and the two individuals i.e Hensonkap Vaiphei and Paominthang Khongsai for verification and conduct formalities.

On arrival at KPI-PS at 6:00 pm, as per the direction of Executive Magistrate, Mr Boipu Vaiphei (27) S/o Mangkholien Vaiphei of Zalenbung village, PS-Litan, Ukhrul District, Manipur opened the seat of Ntorg vehicle B/R. No.AS 05S-7808. It is seen that one black sweat-shirt was found inside the under-seat storage and on being unwrapped the shirt, one black polythene was found and on opening the same, found three similar soap cases (slate blue) containing suspected brown sugar. Meanwhile, the source man had produced one soap case (containing suspected to be brown sugar) which was received earlier from Hensonkap Vaiphei and now the total recovered soap cases is 4 (four). The four soap cases were marked 1, 2, 3 and 4 by using marker pen. On weighing 1, 2, 3 and 4, it is found 1 weigh 40 grams; 2 weighs 38 grams, 3 weighs 39 grams and 4 weighs 39 grams including the weight of the soap cases, transparent plastic packages and rubber bands. The 4 (four) soap cases were kept inside one white polythene and on being weighed again, found a total of 161 grams including the weight of the soap cases, rubber bands and white polythene.

The recovered 4 (four) soap cases (suspected to be containing brown sugar) and other articles were seized in the presence of witnesses, three apprehended persons and executive magistrate by appending their respective signature in the memo as the witnesses of the whole proceeding of Extraction and Weighing by observing legal formalities at 6:20 pm. The three individuals were arrested at 6:30 pm on the same day at KPI-PS.
