

13. First Information contents:

The brief fact of the case is that 14th October 2025, at 1:00 pm received information from one source man regarding the movement of drugs peddlers in one Maruti Suzuki Alto K10 bearing Regn. No. MN-06LB-0838 and one black Auto toward Senapati on NH-2. Immediately, a team led by Addl. SP(LO)/KPI, Special Team of Kangpokpi-PS including women police team led by SDPOs-KPI/GSPM and OC/KPI-PS along with one team of 16 AR, 1 team of A/112 CRPF and 1 team of QAT/112 CRPF under the supervision of SP/Kangpokpi, launched a search operation and conducted frisking & checking on the aforesaid vehicles at different locations along NH-2. While self along with the teams of Special Team of Kangpokpi Police led by the SDPO/Kangpokpi and Women Police along with 16 AR were conducting frisking & checking at Alex Farm, the said Maruti Alto K10 car was approaching toward us and was stopped for verification at around 3:00 pm. The driver/owner was identified as Thongkhopao Lhungdim (51) yrs and the woman occupant as Veineichong Lhungdim who are married couple from C. Munnom village, PO-Motbung, PS- Gannom Sapormeina, Saitu Gamphajol Sub-Division, Kangpokpi District, Manipur. Immediately, the other teams led by the Addl.SP(LO)/KPI were promptly informed about the matter and the missing of the Black Auto. All other teams were also alerted about the missing black Auto. The police teams led by Addl. SP(LO)/KPI rushed towards Alex Farm. While approaching Alex farm, the police team led by the Addl.SP(LO)/KPI and SDPO/GSPM found one black Auto suspiciously taking a U-Turn. Immediately, SDPO/GSPM team led by Addl. SP(LO)/KPI followed the black Auto and I was informed to join them in pursuing the black Auto. The black Auto was seen speeding towards Kangpokpi. The Police teams pursue the black Auto which was proceeding towards Kangpokpi District Hospital. The team then found one black Auto without a licensed Registration number plate parked beside the road near District Hospital. In the meantime, one person who was walking briskly in a suspicious manner was stopped and on questioning him, he disclosed that he is the owner of that black Auto who fled in front of the police teams. He identified himself as Thangminlun Haokip (33) yrs S/o Thanghao Haokip of T. Thangkan village, PS-Saikul.

Kangpokpi District, Manipur. By observing formalities, Thangminlun was given an option whether his body and belongings be searched or disclosed what was concealed inside the hand bags that were loaded in between the rear seats. Thangminlun disclosed about the presence of contraband drugs inside the bags and he disclosed that the drugs belong to one individual named Mrs. Veineichong of Saparmaina village who were travelling in a Maruti Suzuki Alto. Meanwhile, the two individuals who were detained near Alex Farm were taken to KPI-PS for further checking.

On confirming the presence of illegal drugs, executive magistrate of Kangpokpi was intimated and requested for his presence at the PO. As requested, one Executive Magistrate arrived at the PO i.e near District Hospital, Kangpokpi at 4:35 pm and as per the direction of duty Magistrate, Thangminlun took down the hand bags and took out the concealed soap cases (suspected to be containing brown sugar) from the three hand bags one after another and found a total of 225 (two hundred twenty-five) soap cases on counting. The soap cases were marked 1, 2, 3,till 225 for proper identification. The soap cases marked 1 to 50 were kept inside one transparent polythene bag and marked as Lot-1. Similarly, the soap cases marked 51 to 100 were kept inside transparent polythene bag and marked as Lot-2 ; 101 to 150 soap cases were kept inside polythene bag and marked as Lot-3; 151 to 200 soap cases were kept inside one polythene bag and marked as Lot-4 and 201 to 225 soap cases were kept inside one polythene bag and marked as Lot-5. On trying to weigh the Lots, the weighing machine was too small and cannot obtain accurate result of the weight of the lots. With the permission of the executive magistrate, weighing was done at KPI-PS by weighing all the Lots (i.e. Lot-1 to Lot-5), Lot-1 weighs 2.250 kgs; Lot-2 weighs 2.134 kgs; Lot-3 weighs 2.124 kgs and Lot-4 weighs 2.198 and Lot-5 weighs 1.138 kgs including the weight of the soap cases and rubber bands. Hence, the total weight of the Lots is found as 9.844 kgs including the weight of the soap cases, rubber bands and transparent polythene bags.

The recovered 225 (Two hundred and twenty five) soap cases (suspected to be containing brown sugar) and other articles were seized in the presence of witnesses, three apprehended persons and executive magistrate by appending their respective signature in the memos as the witnesses of the whole proceeding where Extraction and Weighing at 5:33 pm at the PO; One seizure memo at 5: 40 pm at the PO and another seizure memo at 6:10 pm at KPI-PS. Thangminlun Haokip was arrested at 5:50 pm at the PO and the other two detainees were arrested at 6:20 pm on the same day at KPI-PS.


