The brief fact of the case is that on 12/11/2025, combined teams (Total- 96 strength) comprising of Kangpokpi District Police led by Shri Lhunminlal Khongsai, MPS, SDPO/Kangpokpi, OC/KPI-PS team led by Inspt. Henminthang Kipgen, Reserve Line Kangpokpi and Chalwa-PS team led by SI Khailet Lhanghal, A/112 Bn CRPF along with a team of Kangpokpi Forest Division and Tamenglong Forest Division under the supervision of SP/Kangpokpi carried out poppy destruction of about 31 acres (approx.) in the adjoining areas of Senapati and Kangpokpi District at Thonglang Akutpa village and Songjang village Hill ranges from 9:30 am to 4:30 pm. During the process 11 (eleven) huts were burnt down, around 8 (eight) bags of fertilizers and 7 (seven) bags of salt were also destroyed. The unknown poppy cultivators are suspected to be from Nepali, Kuki and Naga Communities. At the spot, 3(three) Poppy flower-Pods were seized. The teams arrived back at 6:30 pm on the same day.

Hence, a case under FIR No. 34(11)2025 KPI-PS u/s 18(c) ND & PS Act, 1985 is being registered for investigation.
