The brief fact of the case is that on 15/11/2025, combined teams (Total- 90 strength) comprising of Kangpokpi District Police led by Shri Lhunminlal Khongsai, MPS, SDPO/Kangpokpi, Kangpokpi police team led by SI Hemjamang Khongsai, Chalwa-PS team led by Inspector Brandon Kilong, Reserve Line Kangpokpi team lead by SI Khailet Lhanghal, A/112 Bn. CRPF along with a team of Kangpokpi Forest Division and Tamenglong Forest Division under the supervision of SP/Kangpokpi carried out poppy destruction of about 20 acres (approx.) in the hill ranges of Kotlen village under Kangpokpi District, Manipur from 1000 hrs to 1500 hrs. During the process, 5 (five) huts were burnt down, 3 (three) bags of fertilizers, 2(two) Round-Up Herbicides and 2 (two) bags of salt were also destroyed owned by unknown poppy cultivators. At the spot, 3(three) Poppy flower-Pods were seized. The teams arrived back at 7:00 pm on the same day.

Hence, a case under FIR No. 35(11)2025 KPI-PS u/s 18(c) ND & PS Act, 1985 is being registered for investigation.


