

CRPF under the supervision of OC/KPI-PS immediately rushed to the spot at around 12:10 pm. On reaching near Alex Farm, seen 3 (three) individuals who were extorting money from one loaded truck (Eicher) which was proceeding from Dimapur towards Imphal. With prompt action, the teams managed to overpower and apprehended 2(two) individuals identified as (1) Lamginmang Kipgen (28) S/O (L) Khaihen Kipgen of S. Songtun Village and (2) Janggouhao Misao (26) S/O (L) Thangjalun Misao of Lungphou Village at the spot at 12:30.pm. Whereas, 1 (one) individual managed to escape from the spot taking advantage of thick vegetation nearby. The driver of the Tata Truck who is identified as one Shri Rafiqulislam (30) ys. s/o Sajim Uddin of H/No. 149 East Block Colony, Burma Camp, Dimapur, Nagaland was also assaulted by the three individuals.

Hence, a regular case under FIR No. 37(10)2024 KPI-PS u/s 308(2)/308(3)/131 BNS has been registered for investigation.

I, the undersigned, have the honour to report that, today i.e. 27/10/2024, received a reliable input regarding extortion from loaded trucks plying on NH-2 near Alex Farm. So, a team led by ASI Letminlen Lupheng of KPI-PS along with E/119 Bn. CRPF under the supervision of OC/KPI-PS immediately rushed to the spot at around 12:10 pm. On reaching near Alex Farm, seen 3 (three) individuals who were extorting money from one loaded truck (Eicher) which was proceeding from Dimapur towards Imphal. With prompt action, the teams managed to overpower and apprehended 2(two) individuals at the spot at 12:30 pm. Whereas, 1 (one) individual managed to escape from the spot taking advantage of thick vegetation nearby. The driver of the Tata Truck who is identified as one Shri Rafiqulislam (30) ys. s/o Sajim Uddin of H/No. 149 East Block Colony, Burma Camp, Dimapur, Nagaland was also assaulted by the three individuals. The apprehended two individuals have been handed over to you for necessary legal action
