The brief fact of the case is that 23<sup>rd</sup> November, 2025 at 9:00 am, received specific inputs from one source man regarding the movement of drugs peddler on NH-2 in between Leikop and Kangpokpi Bazar. Immediately, a combined teams of Kangpokpi District Police comprising of SDPO/KPI, SDPO-GSPM, one team of KPI-PS and 16 AR team, led by Shri SL Kamkhohao, MPS, Addl. SP (L & O)/KPI, under the supervision of SP/Kangpokpi, launched a search operation and conducted frisking & checking at different locations along NH-2. The team laid mobile naka along NH-2 in different points from Leikop to Kangpokpi Bazar. At around 12:35 pm the team spotted one person moving in a suspicious manner at Bongmoul village. On searching the said person who is identified as Mr. Lunkhohao Kipgen (43), (chief of Gunphaibung village) s/o Seikholam Kipgen, found one plastic cover (Everyday Milk) containing suspected opium from his possession.

On confirming the presence of illegal drugs, executive magistrate of Kangpokpi was intimated and requested for his presence at the PO. As requested, one Executive Magistrate Shri Kaigoulal Kipgen, SDM, Saikul arrived at the PO i.e Bongmoul village bazaar along NH-2, Kangpokpi at 1:05 pm. As per the direction of duty Magistrate, Mr. Lunkhohao Kipgen took out the concealed plastic cover (suspected to be containing Opium) from his bag. On spot questioning, he admitted that it was his first harvest where he cultivated in the hill ranges of Koubru.
