The brief fact of the case is that today i.e. 01/12/2025, combined teams (Total- 120 strength) comprising of Kangpokpi District Police led by Shri Lhunminlal Khongsai, MPS, SDPO/Kangpokpi, a team of KPI-PS led by Inspt. Henminthang Kipgen, OC/Chalwa-PS and team, 30 (Thirty) Personnel of Reserve Line, Kangpokpi, 20 (Twenty) personnel of GSPM-PS, 2 (Two) Platoons of 112 Bn. CRPF along with 1(one) team of Kangpokpi Forest Division under the supervision of SP/Kangpokpi carried out poppy destruction of about 36 (Thirty six) acres (approx.) in the Hill Ranges of C. Lamjang village from 0830 hrs to 1600 hrs. During the process, 11(Eleven) huts were burnt down, 14 (Fourteen) bags of fertilizers and 9 (Nine) bags of salt were also destroyed owned by unknown Poppy cultivators. At the spot, 3(three) Poppy flower-Pods were seized. The teams arrived back at 4:45 pm on the same day.

Hence, a case under FIR No. 38(12)2025 KPI-PS u/s 18(c) ND & PS Act, 1985 is being registered for investigation.
