

Base on specific input shared by intelligent agency regarding the movement of unknown armed miscreants in the general area of Changoubung Village approx. 3 Kms NW of South Changoubung in Kangpokpi District, Manipur. In response to this information, a column consisting of two Officers, two Junior Commissioned Officers (JCO), sixteen other Ranks (OR) from 16 Assam Rifles, 22 Assam Rifles and District Police Kangpokpi launched a search operation on the inter village road connecting North Changoubung and South Changoubung village today i.e. 9/11/2024 from 0430 hrs to 0730 hrs. During the search operation conducted in the general area of Changoubung by the combined teams, the unknown armed miscreants were already fled away from the scene however, the following items were seized from the jungle between North Changoubung and South Changoubung at 0720 hrs.
