The brief fact of the case is that today i.e. 05/12/2025, combined teams (Total- 123 strength) comprising of Kangpokpi District Police led by Shri L. Lhunminlal Khongsai, MPS, SDPO/Kangpokpi, a team of OC/KPI-PS led by Inspt. Henminthang Kipgen, OC/Chalwa-PS and team, RL/DHQ-KPI and team, one team of Forest Department/Kangpokpi, one team from Narcotics Control Bureau, one team from GSPM-PS, 2 (Two) Platoons of 112 Bn. CRPF under the overall supervision of SP/Kangpokpi carried out poppy destruction of about 48 (Forty Eight) Acres of land (approx.) in the hill ranges of T. Khonomphai (Laloi) village hill ranges under Kangpokpi District. During the process, 27(twenty seven) huts were burnt down, 31(thirty one) bags of fertilizers, 28(twenty eight) Roundup Herbicides were destroyed, 17(seventeen) bags of salt were also destroyed, equipment like spray-pumps, pipes, herbicides etc used in cultivation owned by unknown Poppy cultivators were destroyed and burnt down. At the spot, 3(three) Poppy flower-Pods were seized. The process of destruction was started at 0730hrs and concluded at 1630hrs on the same day.

Hence, a case under FIR No. 40(12)2025 KPI-PS u/s 18(c) ND & PS Act, 1985 is being registered for investigation.
