The brief fact of the case is that on 18/12/2024, a joint teams (total -120 personnel), comprising Kangpokpi District Police and one platoon of E/112 Bn. CRPF and staff of Forest Department led by Shri Tholu Rocky, MPS, Addl SP (I.&O)/Kangpokpi under the supervision of SP/Kangpokpi proceeded from KPI-PS had carried out illegal poppy destruction drive in the hill ranges of Bileijang Village in the presence of Executive Magistrate. The joint teams reached the spot at 08:00 am and successfully destroyed the illegal poppy plants of about 18 (Eighteen) acres in the said hill ranges at 3:30 pm. The approximate value of the destroyed poppy plants is Rs. 1,62,00,000/- (One crore sixty two lakhs only).

Hence, a regular case under FIR No. 42(12)2024 KPI-PS u/s 18(b) ND & PS Act, 1985 is being registered for investigation.
