The brief fact of the case is that today i.e. 19/12/2024, a joint teams (total- 120 personnel), comprising Kangpokpi District Police and one platoon of E/112 Bn. CRP and Staff of Forest Department led by Shri TholuRocky. MPS. Addl SP (L&O)/Kangpokpi under the supervision of SP/Kangpokpi proceeded from KPI-PS had carried out poppy destruction drive in the hill ranges of Makui Village in presence of Executive Magistrate. The joint teams reached the spot at 08:00 am and successfully destroyed the illegal poppy plants of about 25 (twenty five) acres in the said hill ranges at 3:30 pm. The approximate value of the destroyed poppy plants is Rs. 2,25,00,000/- (Two crore twenty five lakhs only).
