The joint teams reached the spot at 09:30 am and successfully destroyed the illegal poppy plants of about 17(Seventeen) acres in the hill ranges of Holjang and 5(Five) acres in the hill ranges of Kotlen; total in both the hill ranges 22 (Twenty two) acres at 3:00 pm. The approximate value of the destroyed poppy plants is Rs. 1,98,00,000/- (One crore ninety eight lakhs only). The teams arrived back at 6:10 pm on the same day.
