The brief fact of the case is that on dated 11.03.2025 at around 1600 hrs, a civil vehicle bearing No. WB61B 7147 (Tata Yodha) provided by state administration to 37 Bn BSF for ops and ADM duty, driven by civil driver namely MD. Apikba, carrying 17 personnel of 'G' Coy 37 Bn BSF while returning from ROP duty from Kangpokpi side towards Tac HQ, IIIT Campus Mayangkhang, Dist-Kangpokpi, met with an accident which fell into deep gorge/ditch approx. depth 40ft on the left side of NH-02 near village Changoubung, Dist-Kangpokpi. In the said incident 17 personnel including the civil driver got injured. All injured personnel including civil driver had been evacuated to the District Hospital, Senapati, where 03 personnel were declared brought dead by the treating doctor.
