

The brief fact of the case is that today i.e. 11/03/2025 a Tata Yodha DI (bearing No. WB61B 7147) hired to be used for 37 BSF deployed in IIIT, Mayangkhang met with an accident at around 4:00 pm near S. Changoubung village along NH-2 about 3 Kms North from Kangpokpi Police Station.

Self (SI Jangkhomang Baite) and ASI Letminlen Lupheng of KPI-PS, leading QRT- 1 & 2 of KPI-PS reached to the spot to assist the injured jawans to be shifted to nearest hospital and to conduct spot enquiry pertaining to investigation. We learned that 17 (seventeen) jawans were seriously injured and 5 (five) in critical condition. The injured BSF jawans were moved to Senapati District, Hospital at about 4:20 pm. When our team escorted the injured jawans after getting first Aid from Senapati District Headquarter towards Imphal for higher medical treatment, we were stopped by an unruly mob of 60-70 miscreants with the malicious intention of delaying timely medical attention and thereby causing threat to the life of injured public servants who were in dire need of treatment. With the criminal intention and force, the mob damaged the Government issued vehicle Tata Yodha DI bearing Regn. No. MN01AA-6307 of KPI-PS at SBI, Kangpokpi junction at about 7:00 pm considering the importance of moving the injured personnel to hospital. The team tactically manoeuvred to avoid any confrontation and reached Police Station along with ambulances in a different route.

Hence, a case is being registered under FIR No. 9(3)2025 KPI-PS u/s 62/221/326(b)/132/324(3)/131/351(2)/126(2)/3(5) BNS for investigation.
