Subject: Application for Registration of FIR.

Sir,

I, Smt. Melody Tingneichong, aged about 46 years, residing at M Molnoi Village, Sugnu, Chakpikarong Block, Chandel, Manipur and presently residing at K Molnom Village, Chandel, Manipur, respectfully submitted this application for registration of an FIR.

That on 5th June, 2023 large-scale communal ethnic violence broke out between the Kuki Zo and Meitei Communities, resulting in grave danger to life and property in the Imphal Area.

That due the imminent threat to our lives, I, along with my 6 family members was escorted by security personnel and we fled from Imphal to churachandpur for our safety.

That, since our displacement, we have been living as Internally Displaced Persons (IDPs), without permanent shelter, and were compelled to shift from place to place from 2023 till date, in the hope of rebuilding our livelihood.

That we could not file an FIR earlier due to the

- Psychological trauma and insecurity caused by the violence, and
- Fear of intimidation and retaliation,
- The disturbed law-order situation.

Hence, the delay in filling this FIR is purely due to circumstances beyond our control.

That, it has now come to our knowledge through reliable sources that our residence at M Molnoi Village, Sugnu, Chakpikarong Block, Chandel District has been looted after we fled for safety.

That at the time of our sudden escape, we were compelled to leave behind all our immovable and movable household properties, which include the following:
