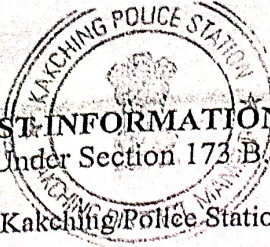

I have the honour to report that today, i.e. 07/02/2026, at about 3:00 pm received a reliable information from 46 AR and further corroborated from our own sources regarding the presence of members of the banned organization KYKL in Kakching Lamkhai area. On received the input, teams of CDO Unit, Kakching rushed to the said area and conducted frisking and checking at along NH-102 Imphal Moreh road at Kakching Lamkhai by establishing a mobile check point.

During the course of frisking & checking one unknown individual matching with the input was noticed coming on foot from Sora side towards Pallel at along NH-102 Imphal Moreh road at Kakching Lamkhai and was detained by our teams.

On preliminary examination at the spot, the individual identified himself as Mohen Takhellambam @ Rengyai (31 yrs) S/o. T. Ibohi Singh, resident of Pallel Maning Leikai, Kakching District.

On further spot questioning, he disclosed that he is an active member of the banned organization KYKL. He joined the banned organization KYKL in February, 2025 and got 30 days of basic military training at Thanga (Karang) through one instructor S/S Lieutenant Babu of Waikhong. He further disclosed that he has been working under the command of one S/S Lieutenant Chingsang @ Brojen of the said banned organization and was tasked to serve monetary extortion demand and collecting extortion money from public and brick field, business establishments of Kakching District. It is highly suspected that he may be involved in various subversive activities carried out by the banned organisation.

Following the disclosures he was arrested from the spot at 3:55 pm by observing formalities. From his possession recovered (a) 1(one) Redmi Note 15G Pro Plus mobile phone IMEI 1-860041058145684/01 & IMEI 2-860041058145692 with Airtel SIM card No. 8415061266. The same was seized from the spot by observing formalities at 4.05 pm and videography of the same was done at spot.

The arrested individual, along with the arrest memo, arrest intimation, and grounds of arrest, are hereby handed over to you for further necessary legal action.

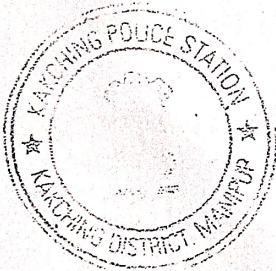
