The program started at 11 am. In that gathering at about 11:35 am some unknown armed miscreants dressed in camouflage with SBBL guns fired in a dangerous way in the name of offering gun salute to the people died in last two years of communal conflict in Manipur between two communities endangering life and safety of people including women and children present there. The program concluded at 2:50 pm

The action of organisers i.e. Kuki Inpi Saikul- 1) President- Thangkam Lumpheng, Nungka village ,2) Vice President-Paokam kipgen, Pangjang village ,3) Gen Secretary- Thangsei Touthang, Molkon village ,4) Information Secy-Ngamkhohao Khongsai, Holbung village, 5) Finance Secy-Lenkhohao Misao, Thangkanphai village , Volunteer Incharge Saikul-Benjamin Mangte and unknown armed miscreants tantamount to violating disobedience orders promulgated by public servant, wearing military garb and resorting firing in a dangerous way endangering life and safety of people present at public place with common intention.

Hence, a suo-motu case under FIR No. 10(5)2025 SKL-PS u/s 168/3(5)/223/196 BNS and 25(9)/25(1C) Arms Act,1959 is being registered for investigation.




